

Sub: Freight concession for Iron- Ore traffic.

1. Sanction of the Central Government is hereby accorded to grant 20% (Twenty Percent) concession in freight on Normal Tariff Rate (NTR) for movement of Iron-Ore booked at Class 200X subject to following conditions.
 - I. The discount will be given to Iron Ore booked at Class-200X at the time of issue of RR.
 - II. Freight Concession will be given for Iron-Ore traffic transported in covered wagon only.
 - III. The originating point of the traffic will be BAY-HPT-CTA sector on South Western Railway.
 - IV. The destination point will be Kakinada port of South Central Railway.
 - V. No other concession will be admissible on this traffic.
 - VI. All other applicable charges, if any, will be leviable.
2. Railway shall furnish a monthly appreciation report by 7th of the following month.
3. These instructions will come into force with effect from 15 . 07.2008 and will remain valid till 30. 09.2008.
4. This issues with the concurrence of the Finance Directorate of the Ministry of Railways.
