

The Federation of Railway Officers' Association (FROA) shall be holding their General Body Meeting and Election for Governing Council on 05.05.2016 & 06.05.2016 in the Conference Hall, Rail Bhawan, New Delhi. Your Railway Organisation/ Unit is advised to grant Special Causal Leave and Passes to the representatives of the Federation to enable them attend the meeting. As per para 1 (d) of Board's letter dated 21/4/79, outstation representatives are allowed three days Special Casual Leave and local representatives are allowed two days Special Causal Leave including the date of the meeting, in addition to journey time. A list of office bearers of the Federation is enclosed. Besides office bearers, four members of the Federation from each Zonal Railway and two members from each Production Unit/RDSO may also be allowed to attend the meeting in terms of Board's letter No. 79/MS/OF/POL.1 dated 21/4/1979 as amended vide letter No. 94/E(GR)II/11/9 dated 21/7/2004.
