Sub: Revision of Pension of pre-2016 pensioners as per 7th CPC.

**Ref:** 1. Board's letter No. 2016/F(E)III/1(1)/7 dated 22.5.2017 (RBE No. 49/2017) & 11.07.2017 (RBE No. 66/2017).

2. Board's letters of even No. dated 9.6.2017,19.7.2017&25.07.2017 (RBA No. 68/2017, 98/2017 & 103/2017).

Attention is invited to Board's letters cited above, wherein instructions regarding revision of pre-2016 pensioners as per the 7<sup>th</sup> CPC recommendations as envisaged by DoP&PW from time to time have been circulated for information and compliance. It was also advised to draw an action plan along with target dates vide letter no. 2016/AC-II/21/8 dated 19.07.2017 &25.07.2017 (RBA no. 98/2017 & RBA no. 103/2017).

In the meanwhile, Department of Pension and Pensioner's Welfare (DoPPW) vide their Office Memorandum No. 4/23/2017-P&PW(D) dated 25<sup>th</sup> July, 2017 has brought out the procedural actions required to be taken for revision of Pension (Copy enclosed). Para 3 of the letter envisages that Ministries/Departments are once again requested to **suo moto** proceed to process the revision cases immediately to avoid delays in issuance of revised PPOs of pre-2016 retirees. It may be noted that expeditious revision of Pension requires a close coordination between Personnel and Accounts Departments. The CPO and PFA may be asked to form joint groups by drafting staff from both the departments for expeditious revisions.

The status of revision of PPOs is being reviewed by Department of Pension and Pensioners' Welfare, status of Revision Cases as on 16/8/2017 is to be send by 21/8/2017. In addition, Secretary (Expenditure), Ministry of Finance, vide his DO letter dated 27/7/2017, has asked for a weekly to be sent regarding progress of revision of Pension Cases. It is requested that necessary steps may kindly be taken to expedite the task of revision of the remaining cases. The progress made by 16/8/2017 may kindly be apprised to Board in the enclosed format by 21.8.2017 by mail at 7cpcac2rb@gmail.com.

## OFFICE MEMORANDUM

Subject. Implementation of Government's decisions on the recommendations of the 7<sup>th</sup> Pay Commission-Revision of Pension of pre-2016 pensioners/family pensioners etc- Procedural actions for revision.

The undersigned is directed to say that orders for revision of pension of pre-2016 pensioners/family pensioners by notional pay fixation in the 7<sup>th</sup> Central Pay Commission Matrix have been issued vide this Department's O.M. No.38/37/2016 P&PW(A) dated 12.05.2017. Subsequently, concordance tables for fixation of revised pay and pension/family pension of pre-2016 pensioners/family pensioners have also been circulated vide this Department's O.M. No. 38/37/2016-P&PW(A) dated 06.07.2017.

- 2. Attention of Ministries/Departments is invited to Para-18 of this Department's O.M. 38/37/2016-P&PW(A) dated 12/05/2017 whereby responsibility has been cast on Head of Department and Pay and Accounts Office attached to the office from which the Government servant had retired or was working last before his death to revise the pension/family pension of pre-2016 pensioners/ family pensioners with effect from 01.01.2016
- 3. It has, however, come to the notice of this Department—that the process of revision of pension/family pension of pre-2016 pensioners/family pensioners has not yet been started by a large number of Ministries/Departments/Organizations/Offices. It has also been brought to the notice of this Department that pensioners/family pensioners are being asked to make a formal application for revision of their pension/family pension. The instructions issued by this Department do not provide for submission of application by individual pensioners/family pensioners for revision of pension/family pension. Ministries/Departments, etc. are, therefore, once again requested to suo moto proceed to process the revision cases immediately to avoid delays in issuance of revised PPOs of pre-2016 retirees.

4. All the Ministries/Departments are also requested to furnish the status of <u>revised</u> cases as on 16-08-2017 in the enclosed proforma so as to reach this <u>Department</u> latest by 31-08-2017.
