OFFICE ORDER NO. 23 OF 2017

Sub: Creation of GST Cell in Board's Office

It has been decided to create a cross functional Goods and Services Tax (GST) Cell in Board's Office to function as the Nodal wing for interaction with all the Zonal Railways/PUs to facilitate faster implementation of GST and also to co-ordinate with GST Section of M/o Finance.

2. The cell would comprise nominated Executive Director/Director level Officers from different streams/Directorates for monitoring the daily activity with regard to implementation of GST and other issues related therein. The constitution of GST team would be as under:-

2.1 The nominated ED/Director level Officers would be the Nodal Officers for GST related work pertaining to Directorate/Department to which they belong. Further, they would handle GST work in addition to their existing workload.

2.2 The GST Cell would be headed by Adv./Accounts.

2.3 For the purpose of secretarial assistance, AC-II shall be the Nodal Section

3. Broad Items of work to be handled by GST Cell would be as under:-

- (i) Coordination with GSTN and GST Secretariat on relevant GST matters
- (ii) Coordination with Zonal Railways for ensuring rollout of GST arranging formal/periodical meeting obtaining feedback from Nodal Officers.
- (iii) Taking decision on ensuring Business Process Reengineering to ensure protection of Railways interest and leveraging the new GST Law for benefit of Indian Railways.
- (iv) Dealing with policy matters pertaining to GST as applicable in Indian Railways
- (v) Taking decision on IT intervention required for smooth rollout of GST.
- (vi) Issue of formats and documentation as required for Management Information System under GST, Act.
- (vii) Recommending changes in Codes and Manuals of the respective Departments for ensuring GST compliance.
- (viii) Serving as referral body on issues raised by Zonal Railways/Production Units for seeking clarification from Department of Revenue.

4. The above issues with the approval of the Competent Authority.
