# Subject: Format for GST related Manual Data Entry.

Enclosed please find a detailed instruction from CRIS for the utility that has been created for uploading of Manual Transactions relating to Commercial, Engineering, Sale of Scrap, etc where Railways are responsible for levy of GST and collection of the same. The enclosed letter includes format (Annexure 'A') to capture all GST related details in Manual Transactions, which will also serve as an invoice for those transactions where a receipt has to be given to the customer. Instructions to fill information as brought out in Annexure'A' is attached in Annexure'B'.

The format also encloses a Screen Snap Shot of the utility (Annexure 'C') that has been created which is now available at the web-site link <a href="www.gst.indianrail.gov.in">www.gst.indianrail.gov.in</a>. May kindly ensure that the format for Manual Transactions of receipt and the Screen Snap Shot for data entry is given wide publicity, right upto field formations at stations, depots where sale of scrap takes place, and other establishments where railway receipts are collected in non-computerized formats.

The manual input tax form is attached for your perusal and further circulation to all the Railways. The online utility form is also attached and can be accessed on the CRIS website at <a href="www.gst.indianrail.gov.in">www.gst.indianrail.gov.in</a>. This utility form can be filled in, based on the data captured in the manual input form and submitted directly to the CRIS server for further aggregation and onward submission to the designated agency of Indian Railways for further submission to the GSTN.
