**Sub: Transfer/swapping of HAG/SAG IRSSE posts between NWR and NR.**

In terms of Board's sanction (Corrigendum) No. 2016E(GC)16-9(Cadre Review) (Vol-III) (IRSSE)(31-A) dated 24.10.2019, HAG/IRSSE post of CSTE/Proj-I (PC:10ER3P002) of ER was transferred to NWR for operation as SDGM/NWR. It has now been decided to transfer the aforesaid HAG/IRSSE post (PC:10ER3P002) from NWR to NR and transfer the SAG/IRSSE post (PC:10RB4P004), earlier transferred from RB to NR, to Eastern Railway on swap basis.

2. Hence, sanction No.2020 E(GC)12-11 (50) dated 30.06.2020 may be treated as cancelled.
3. Sanction of the Ministry of Railways is hereby accorded to transfer the HAG/IRSSE post (PC:10ER3P002) from North Western Railway to Northern Railway and transfer the SAG/IRSSE post (PC:10RB4P004), earlier transferred from RB to NR, to NWR on swap basis.
4. NWR & NR should advise each other immediately about date of release of the posts under intimation to Board's office. Operation of HAG/IRSSE post (PC:10ER3P002) at NR and SAG/IRSSE post (PC:10RB4P004) at NWR will be effective from the date of release of the posts by NWR & NR respectively or from the date of actual operation of the posts at NR & NWR, whichever is later.
5. This issues with the concurrence of the Finance Directorate of the Ministry of Railways.


