A meeting was held in the Chamber of Adviser (Industrial Relations) on 7.4.82 to review the implementation of the revised Running Allowance Rules and discuss problems arising therefrom when senior representatives of your Railway (except N.Rly.) were present.

2. The record note of the discussions held in the Chamber of Adviser (IR) is enclosed for your perusal and further necessary action. Points of doubt raised by Zonal Railways in the implementation of instructions contained in Board's letter No. E(P&A)II-80/RS-10 dated 17.7.81 would stand clarified as per record note of discussion.

3. The Board would further desire to clarify that while the instructions dated 17.7.81 have been issued in the context of accepted recommendations of the Running Allowance Committee, there have been deviations/modifications of the Recommendations of the Running Allowance Committee while issuing the Board's order dated 17.7.81. Therefore, if there is any conflict between the recommendations of the Running Allowance Committee and the orders contained in Board's letter of 17.7.81, the orders contained in Board's letter of 17.7.81 should be treated as final and if the position is still not clear, the Board may be approached for necessary clarifications.

4. Please expedite submission of reports of confirmation in writing about the total implementation of the new Running Allowance Rules together with full details thereof as called for in Para 4 of the Record Note of Discussions.
