

**Appointment of Liaison Officers for looking after the matters relating to OBCs.**

The question of nominating the Liaison officers for OBCs was under consideration by the Board and the Board have decided the CPOs/Zonal Railways and Production Units will be the liaison Officers where CPO is not there the officer who has been required to discharge the functions of CPO will be Liaison Officer for OBCs. The Liaison Officer will discharge his/her assigned duties with the assistance of an APO in the Headquarters Office and also with the help of APO in the Divisions/Workshops Offices :-

- (a) Ensuring the due compliance by the subordinate appointing authorities with the orders and instructions pertaining to the reservation of posts in favour of OBCs and all admissible benefits;
- (b) Ensuring (i) submission by each subordinate appointing authority's annual, half yearly, quarterly and monthly statements ; and (ii) ensuring scrutiny and consolidation of above statements in respect of all the establishments and services in and under the control of each Railway Administration or Offices and sending the consolidated statements to the Board; and
- (c) Conducting annual Inspection of rosters maintained by the Railways with a view to ensure proper implementation of reservation orders.

The nominated APO in the Headquarters Office will be filled as far as possible from among the officers belonging to this category so that he may be well equipped to ensure the justice to the OBCs.
