Sub: Grant of 'No Objection Certificate' (NOC) to local bodies / State Govts. for major repairs/improvement of roads and footpaths at their own cost in Railway land/premises.

The matter regarding issue of guidelines for grant of 'No Objection Certificate' (NOC) to Local Bodies/State Govts. for major repairs/improvement of roads, footpaths at their own cost in Railway premises/portions, has been under consideration of Board for some time.

2. The matter has been examined and approval of Ministry of Railways is hereby communicated to issue 'No Objection Certificate' (NOC) to Local Bodies/State Govts. for undertaking major repairs/ improvement of roads (including drainage), footpaths at their own cost in Railway premises/portions on case to case basis by Principal Chief Engineer/Zonal Railways with the concurrence of FA&CAO, if following conditions are met with:


- (i) No encumbrance in any manner is caused/created by the agency in railway land.
- (ii) The entire cost of major repairs/improvement of road/footpath is borne by the concerned Local bodies/State Government authorities/other agencies.
- (iii) No additional / new access rights / right of way to be created.

3. Site specific conditions can be added by the Railway to safeguard Railway's interest.

4. Before giving physical access to commence the work, Railway shall satisfy itself about the availability of funds and contractual agency for the entire work including mobilization of adequate men and material for the work. Railway shall also satisfy itself about standards of materials & works being adopted by executing agency.

5. No D&G and supervision charges may be levied for such works.
