

Sub: Procurement of Spares, Consumables and Small Tools required for maintenance of Track Machines.

Ministry of Railways has examined the powers of procurement of above items and have decided to delegate the full powers of procurement of spares, consumables and small tools to the officers of Engg. Department, dealing with Track Machines.

These powers are delegated as below:

- (A) For Planned Procurement of the Track Machines Spares Consumables and Small Tools:
- (i) Chief Engineer Same as that of COS
- (ii) Chief Engineer (TMC) Same as that of CMH
- (iii) Dy.Chief Engineer(THC) Same as that of Dy.COS
- (iv) XEN(Track Hachines) - Same as that of SSO

The Tender Committee, wherever necessary, may be consitututed with the Engg. Officer of appropriate level as the convenor and other members from Finance and Stores Deptt. as per the Schedule of Powers delegated on the Zonal Railways.

In case of proprietory items, necessary certificate should be accorded by the competent officer of the Indenting Department.

- (8) For Emergency Repairs and Purchase of Spares incidental to such repairs:
- (i) PHOD, HOD, DRM U and ADRM f
 - Upto Rs.1 lakh per break down, with finance concurrence.

(ii) Dy.CE/TT

Upto Rs.20,000 per break down without Finance concurrence where purchase of PAC spares is not involved.

Where purchase of PAC spares is involved, each PAC item costing more than Rs.10.000/- should be purchased with prior Finance concurrence
