Kindly recall this office letters under reference vide which Zonal Railways were advised to review the position in respect of all the track machines supplied in the past and complete the condemnation process wherever the same have become unserviceable and beyond economical repairs. An extract of the position obtained from TMS regarding machines which have been entered by Zonal Railways as "Stabled for Condemnation" is enclosed for ready reference. While this may not be a complete list of all the machines which may have become unserviceable, it does reveal that there are a large number of machines which are stabled for last several months whereas the proposal for condemnation is yet to be submitted for Board's approval.

You are requested to review the reasons for the delay and take necessary remedial measures to expedite the due condemnation process.
