I. COMPANY PROFILE

RITES was incorporated under the Indian Companies Act, 1956 with an objective to provide comprehensive consultancy services under a single roof in sectors of infrastructure such as railways, airports, ports and harbours, highways, urban transport, inland waterways, bridges, urban development and town planning and ropeways and management thereof. RITES is internationally recognised as a leading consultant with operational experience in over 55 countries in Africa, Middle East, South East and Latin America. RITES Limited is a schedule –'A'/ Miniratna CPSE under the administrative control of Ministry of Railways.

The authorised and paid up capital of the Company is Rs.300 crore and Rs.200 crore respectively as on March 31, 2017.

Its Registered and Corporate offices are in New Delhi and Gurgaon, Haryana respectively.

The shareholding of the Government of India in the Company is 100%.

II. JOB DESCRIPTION AND RESPONSIBILITIES

Director (Projects) is a member of the Board of Directors and reports to CMD. He is required to discharge statutory and corporate responsibilities for the efficient and profitable operations of the Company. As the professional head, mainly of the Civil Engineering Projects' discipline, he is expected to direct and provide technical guidance to the various consultancy service groups.

2. EMPLOYMENT STATUS:

The applicant must, on the date of application, as well as on the date of interview, be employed in a regular capacity – and **not** in a contractual/ad-hoc capacity – in one of the followings:-

- Central Public Sector Enterprise (CPSE) (including a full-time functional Director in the Board of a CPSE);
- Central Government including the Armed Forces of the Union and All India Services;
- State Public Sector Enterprise (SPSE) where the annual turnover is ***Rs 2000 crore or more**;
- Private Sector in company where the annual turnover is ***Rs 2000 crore or more**.

(* The average audited annual turnover of three financial years preceding the calendar year in which the post is advertised shall be considered for applying the approved limits)

3. QUALIFICATION:

The applicant should be an Engineering graduate with good academic record from a recognized University/ Institute.

Applicants holding MBA/ Post Graduate Diploma in management will have an added advantage.

4. EXPERIENCE:

The applicant should possess adequate technical/ operational/ project management experience at a senior level in a large organization of repute, out of which at least five years in the last ten years should have been in Project Planning & Management/ Design & Consultancy.

Experience in consultancy/ technology/ projects in areas like Rail Transport/ Infrastructure will have an added advantage.

5. PAY SCALE/ RANK/ LEVEL:

The minimum length of service required in the eligible scale/rank/level will be one year for internal candidates, and two years for others as on the date of vacancy.

(c) Applicants from State Public Sector Enterprises/ Private Sector should be working at Board level position or at least a post of the level immediately below the Board level.

6. CONDITION OF IMMEDIATE ABSORPTION FOR CENTRAL GOVERNMENT OFFICERS

Central Government Officers, including those of the Armed Forces of the Union and the All India Services, will be eligible for consideration only on immediate absorption basis.

IV. DURATION OF APPOINTMENT

The appointment shall be for a period of five years from the date of joining or upto the date of superannation or until further orders, whichever is earlier.

- (d) Self-attested copies of documents in support of age and qualifications;

VI. UNDERTAKING BY THE APPLICANT

- a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.
- b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.

3. For candidates from SPSE/ Private Sector

- a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.
- b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.

4. In the above cases, no request for relaxation or otherwise would be entertained.
