I. COMPANY PROFILE

Braithwaite and Co. limited (BCL) was incorporated on 01.12.1976 when the assets acquired by the Government of India under "Braithwaite and Company (India) Limited (Acquisition and Transfer of Undertakings) Act, 1976" were vested with BCL after its takeover by the Government. BCL is a schedule-'B'/BIFR/BRPSE referred, sick taken over CPSE in Heavy Engineering sector under the Administrative control of M/o Railways.

BCL has its registered and corporate offices at Kolkata, West Bengal.

The authorized and paid up share capital of the Company were Rs 95 crore and Rs 33.42 crore respectively as on March 31, 2017.

II. JOB DESCRIPTION AND RESPONSIBILITIES

Director (Production) is a member of Board of Directors and report to the Chairman & Managing Director.

He is responsible for coordination & control of production and maintenance work including procurement and stocking of materials.

III. ELIGIBILITY

2. EMPLOYMENT STATUS:

The applicant must, on the date of application, as well as on the date of interview, be employed in a regular capacity – and **not** in a contractual/ad-hoc capacity – in one of the followings:-

- (c) State Public Sector Enterprise (SPSE) where the annual turnover is *Rs 750 crore or more;
- (d) Private Sector in company where the annual turnover is *Rs 750 crore or more.
- (* The average audited annual turnover of three financial years preceding the calendar year in which the post is advertised shall be considered for applying the approved limits)

3. QUALIFICATION:

The applicant should be an Engineering graduate from a recognized University/ Institution with a good academic record.

Applicants with Technical /MBA qualifications will have added advantage.

4. EXPERIENCE:

The applicant should possess adequate technical/ operational experience at a senior level in a large organization of repute, out of which at least five years during the last ten years should have been in major production/manufacturing units/ workshop/ wagon & rolling stock maintenance depots.

5. PAY SCALE/ RANK/ LEVEL:

The minimum length of service required in the eligible scale/rank/level will be one year for internal candidates, and two years for others as on the date of vacancy.

6. CONDITION OF IMMEDIATE ABSORPTION FOR CENTRAL GOVERNMENT OFFICERS

Central Government Officers, including those of the Armed Forces of the Union and the All India Services, will be eligible for consideration only on immediate absorption basis.

IV. DURATION OF APPOINTMENT

- (d) Self-attested copies of documents in support of age and qualifications;

VI. UNDERTAKING BY THE APPLICANT

Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.

3. For candidates from SPSE/ Private Sector

- a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.
- b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.
- **4.** In the above cases, no request for relaxation or otherwise would be entertained.
