## ANNEXURE I

### CONDITIONS OF SERVICE IN COMMISSION OF RAILWAY SAFETY

1. The Commission of Railway Safety is under the administrative control of Ministry of Civil Aviation.
2. The Commission, which is head by a Chief Commissioner of Railway Safety (Headquartered at Lucknow) has 09 (nine) Circle Offices of Commissioner of Railway Safety, each headed by Commissioner of Railway Safety (CRS) and one circle office of Commissioner of Metro Railway Safety (CMRS) at New Delhi.
3. 60% of the total number of posts of Commissioners of Railway Safety are to be filled up from amongst officers of IRSE and remaining 40% from IRSME/IRSEE/IRSSE/IRTS. The post is filled up by absorption of officers holding analogous post on regular basis or with five years of regular service in posts in the scale of Senior Administrative Grade (SAG) in pay in pay band 4 with grade pay of Rs.10,000/- and who are below 56 years of age. The post of Chief Commissioner of Railway Safety is to be filled up by promotion from amongst Commissioners who have put in at least three years of service in the grade of Commissioner of Railway Safety.
4. No application of withdrawal of application/candidature will be entertained once the application/candidature is received.
5. While in service and also after retirement, Commissioners of Railway Safety will continue to avail all the benefits (Passes, Inspection carriage for tours, medical attention through Railway Hospitals, residential accommodation in Railway Colonies etc.) as are admissible to serving/retired Railway Officers of equivalent grade. Commissioners of Railway Safety are also governed by Indian Railway TA Rules.
6. Officers absorbed in the Commission of Railway Safety will be on probation for a period of one year. After satisfactory completion of one year service, their confirmation in the Commission will be processed.
7. The selected candidates can be posted in any of the circle offices of the commission located at New Delhi/Lucknow/ Bangalore/ Secunderabad / Kolkata / Mumbai, as per the available vacancy at the time of appointment.
